#### 2) PURPOSES OF THE DATA PROCESSING

## 3) COMMUNICATION OF THE DATA

## 4) CONFERRAL OF THE DATA

The conferral of the data for the purposes as per point 2) is mandatory and any refusal of authorisation leads to the exclusion from participation in the assignment of the accommodation. The processed data is that which is provided by the declarer at the time of presentation of the application for the assignment of accommodation.

# 5) DATA RETENTION

In observance of the matters envisaged by Article 5.1, letter e) of the EU Regulation No. 2016/679, the personal data collated will be retained for a period of time no longer than the achievement of the purposes for which the data was collated and processed and in observance of the timescales envisaged by the law.
