### 1) DATA CONTROLLER

### 2) PURPOSES OF THE DATA PROCESSING

The collation and the processing of data referring to yourself is carried out for the purpose of permitting the Foundation to assess your request for admittance to the Calls for the assignment of the accommodation.

### 3) COMMUNICATION OF THE DATA

### 4) CONFERRAL OF THE DATA

The conferral of the data for the purposes as per point 2) is mandatory and any refusal of authorisation leads to the exclusion from participation in the assignment of the accommodation. ### 5) DATA RETENTION
